### IMPORTANT – ARE YOU READY FOR THE SCHOOL YEAR?

The information enclosed in this packet is extremely important and can guarantee that we start the academic year smoothly and productively. **Please carefully read each item, put the important dates calendar on your refrigerator, complete and submit the necessary documents and start checking the website in mid-August for the Scholar-Family Handbook and full school calendar.** Here are a few additional reminders:

1. **Health Forms** - Be sure to submit all the necessary health forms to the Wellness Suite. Your child will not be able to check in on August 25<sup>th</sup> without an up-to-date immunization record and recent physical examination on file. If you need to contact one of our nurses, you may do so by calling 202-248-3008.
2. **Residency Verification** - Ensure you have proven DC residency with the Office of Family & Community Engagement (also known as the FACE Office) if you have not already done so. This process must be completed in person with a member of the FACE Team. **The deadline is July 19<sup>th</sup>.**
3. **Uniform Purchase on Campus** - Attend the uniform roadshow to begin purchasing school uniforms. For your convenience, our uniform supplier, **Risse Brothers will be on campus August 3<sup>rd</sup> from 4:30 p.m. - 7:00 p.m. for families to come and purchase uniform items- shirts, sweaters, and fleece jackets.** Uniform bottoms can be purchased at the store of your choosing. Remember, khaki/tan pants, shorts, or skirts only – NO JEANS, LEGGINGS, JEGGINGS, CARGO PANTS, CARGO SHORTS, OR CARGO SKIRTS.

Dear SEED School Community,

The mission of the DC Department of Health (DOH) is to support people in making healthy choices that create a positive impact on them both today and in the future. Studies confirm that good practices during adolescence carry forward into adulthood. Statistics show that many DC youth are sexually active, and that sexual debut is occurring at younger ages. Teenage pregnancy and rates of sexually transmitted infections (STI), particularly chlamydia and gonorrhea, remain high among DC youth.

Due to the serious health concerns, DOH continues to partner with SEED PCS to make condoms available to all students, effective 3/26/15, through the Revised Condom Availability Policy. Studies show that when used consistently and correctly, condoms are highly effective at in reducing the risk of HIV, STIs and pregnancy. The HIV/AIDS, Hepatitis, STD, and TB, Administration (HAHSTA) within the DOH initiated a program in 2010 to increase condom use among sexually active young people, enhance condom availability in schools and build greater competency in sexual health at both the adult and student levels.

The WRAP MC (Master of Condoms) program trains and certifies individuals as Wrap MCs in condom education. DOH-HAHSTA provides certificates, condoms, and informational and promotional materials to the Wrap MC Program. At this time, DOH has Wrap MCs in 16 DCPS high schools and 17 public charter schools. Overall, the DOH-HAHSTA has certified more than 200 Wrap MCs throughout the District. In addition to increasing the visibility and accessibility of condoms for the District's young people, the Revised Condom Policy also has ensured that hundreds of DC residents who work with youth have accurate and up-to-date information on condoms and sexual health.

SEED PCS may expand the Wrap MC program include high school students in condom distribution efforts. This peer-based approach has long been advocated for by youth-serving community organizations. Increasing youth involvement will increase the visibility of Wrap MC, thus increasing the number of sexually active students who know how to access condoms.

Trained peer educators are a proven, credible source of information for some young people. By serving as positive role models, peer educators produce greater attitude changes in adolescents' perception of personal risk of HIV and STD infection compared to adult-led sessions. Youth who are counseled by peers may be more likely to engage in interactive discussion and take actions to reduce disease transmission. Studies show that adolescents who believe their peers are using condoms are more than twice as likely to use condoms. Furthermore, peer educators have been proven to retain more sexual health knowledge, hold more positive attitudes, and report fewer risk behaviors themselves.

**Frequently Asked Questions (FAQ) about the Wrap MC Program**

Currently, SEED PCS offers a comprehensive sexual health curriculum that is developmentally appropriate for students that is implemented during the Student Life Program. A parent can sign a form opting out his/her child from participating in the curriculum at any grade level, however, DC law allows minors to consent for themselves to receive sexual health, mental health and substance use treatment services.

**Will having condoms available at school condone sex?**

Data show that having access to condoms does not increase instances of teenage sexual behavior, or encourage teens to have sex, but it does increase instances of teenagers engaging in SAFE sexual behavior. No one will force students to take condoms, and no one will pressure young people to be sexually active. The Wrap MC program is designed as a health education program, encouraging anyone who does have sex to always use protection. Data show that having access to risk reduction materials (such as condoms) does not lead to increased risky behavior. The DC Department of Health, DC Public and Charter Schools, and OSSE are committed to keeping young people in the District safe and healthy.

Dear Parent or Guardian:

The District of Columbia Department of Health (DOH) is sponsoring preventive dental services at your child's school through the DOH School-Based Oral Health Program. Licensed dentists and their staff will provide exams ("checkups") and x-rays to students who have not seen a dentist in the last six (6) months. The services will include: dental cleanings, fluoride treatments, and sealants (as needed). Students that need services not offered at the visit (such as fillings, tooth removal, or braces) will be referred to community dentists. Services do not include drillings or shots. Information from your child's visit will be shared with the school nurse or other point of contact at the school and with the DOH School-Based Oral Health Program for the purposes of: billing, treatment and follow-up, and program monitoring.

PLEASE NOTE: Children should see their dentists every six (6) months. If a child has a regular dentist, the School-Based Oral Health Program services should NOT take the place of a visit to that dentist. If a child has been to the dentist in the last six (6) months, she or he may not need the school-based services. The dental providers will check for dental insurance coverage and the last dental visit for all children to be seen at the school and will bill insurance for any services provided.

SEED PCS is excited to remind families of an ongoing partnership with Mary's Center. The partnership allows for SEED to provide scholars access to pregnancy and sexually transmitted infection (STI) testing, options counseling, family planning education, and case management care coordination services to interconceptional (any woman/female who is of childbearing age) and perinatal (pregnant) women. These services are offered to students who attend DCPS schools through the DOH Health Centers at various DCPS high schools.

Mary's Center's is a Federally Qualified Health Center whose mission is to build better futures through the delivery of health care, education, and social services. They embrace culturally diverse communities whose needs too often go unmet by the public and private systems, and provide them with the highest quality of care, regardless of ability to pay. Mary's Center uses a holistic, multipronged approach to help participants access individualized services to set them on the path toward good health, stable families, and economic independence.

These services will be available to all students enrolled at SEED and will be provided in SEED's Wellness Suite between 3:30 pm and 5:00 pm on the first and third Wednesday of each month. If scholars require in person doctor appointments, SEED will provide transportation to and from the appointment. Mary Center's clinic is located at 2333 Ontario Rd NW, Washington, DC 20009.

It's important to note that the services provided to SEED scholars by Mary's Center are confidential. This means, under Rule: 22-B600.7 of the DC Municipal Regulations (Minor Health Consent), services provided by Mary's Center will not be shared with parents unless the students are in danger of hurting themselves or others and/or scholars decide to share information with their parents.

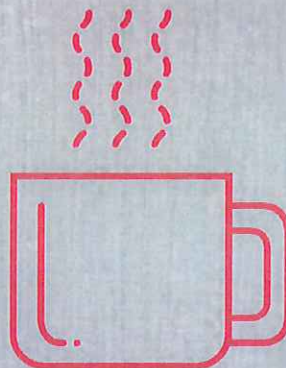

# ATTENTION HIGH SCHOOL STUDENTS!



### Community Service

In addition to completing SEED's intensive high school curriculum, students must complete at least 100 hours of community service to graduate. Additionally, SEED has adopted a school goal regarding community service that 100% of students will have the required number of community service hours at the end of each academic year.

- 9th Grade: 25 hours
- 10th Grade: 50 hours
- 11th Grade: 75 hours
- 12th Grade: 100 hours

**Please note that hours prior to 9th grade do not count towards the requirement – this includes the summer before the start of students' freshman year.** Students will independently manage this graduation requirement by securing opportunities to serve over the weekend and during holiday/summer breaks. However, SEED will coordinate projects and activities as well as share opportunities with students that they can take advantage of during the school week. Submission of SEED tracking sheets and supporting documentation or a letter on official letterhead from the organization that includes name of student, number of community service hours performed and the dates, type of activity, and name and contact information of the on-site supervisor should be turned into the Director of Experiential Learning and External Opportunities.

Forms should be turned in by the following dates:

- Summer hours by September 30th
- End of first semester for hours accrued/service performed in S1
- End of second semester for hours accrued/service performed in S2

All service hours must be completed through a 501(c) (3) non-profit organization or a federal, state, or local government agency. Additionally, hours may be completed through school projects or activities pre-approved by the Director of Experiential Learning and External Opportunities. Service hours must be completed under the supervision of an adult at the agency or organization. This on-site supervisor must be identified and is responsible for verifying the student hours and providing on-site supervision for the service activities. The on-site supervisor may not be the student's parent or close relative.

### Examples of Acceptable Activities

- Tutoring students
- Making toiletry kits for a homeless shelter
- Instructing senior citizens on computer use
- Preparing or serving food at a food bank
- Participating in a park or neighborhood clean up

### Examples of Unacceptable Activities

- Babysitting, performing chores, or hair styling
- Donating items such as money, food, or clothes
- Performing any activity where a student receives payment or a grade
- Participating in traditional school activities such as student government meetings, choir rehearsal, athletics, theater, or similar organization/club, etc.

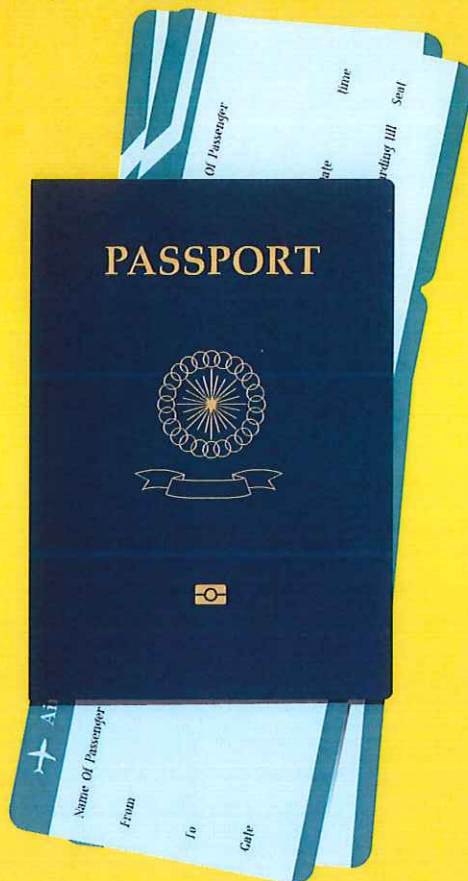

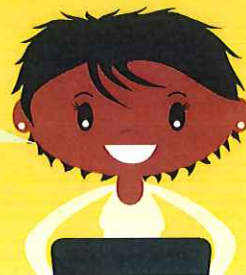

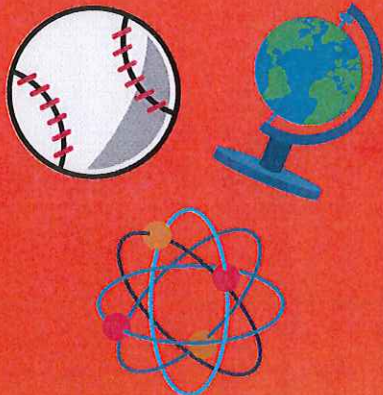
